ORDER

In the circumstances stated by Director, Higher Secondary Education in the letter read as 6th paper above, sanction is accord for the payment of remuneration at the rate of Rs. 500/- per day to the Higher Secondary School Teachers (Junior) and Rs. 600/- per day to the Higher Secondary School Teachers appointed on daily wages for conducting Higher Secondary classes in the academic year 2011-12 onwards subject to the following conditions:-

- 1) *The teachers so appointed should be qualified as per the Special Rules*
- 2) *They should have been within the age limit as on the date of their appointment*
- 3) *They should have worked or should have been working against the sanctioned post of HSST/HSST (Junior).*

- 4) If any of teachers engaged on daily wage basis are absorbed against the newly sanctioned posts, their earlier service will in no way be counted for any service benefit including pension.
