ORDER

As per the Government Order read as second paper above, orders have been issued revising the pay and allowances of State Government employees and teachers wherein as per para 47(2), it has been stipulated that the pension contribution of employees who come under National Pension System, on the basis of revised scale of pay will be recovered from the salary for the month of March 2021 onwards. By the Government Order read as first paper above, it has been ordered that the payment of arrears of Pay Revision and Dearness Allowance shall be made only after deducting the 10% NPS contribution and crediting the same into the PRAN account of the employee along with the Government contribution since arrears are also a part of Basic Pay and Dearness Allowance. The Director of Treasuries vide letter read above requested to clarify whether NPS deduction is being made from the Pay Revision Arrear.

2. Government have examined the matter in detail and are pleased to order that para 47 (2) of the Government Order read as 2nd paper above shall be substituted as follows:

The arrears of Pay Revision from 01.07.2019 to 28.02.2021 as directed at para 43 shall be credited to the PF accounts of employees after deducting 10% of pay revision arrears from each instalment as NPS contribution.

3. The G.O read as 2nd paper above stands modified to this extent.


